



RESOLUTION NO. 004-2016

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

*A RESOLUTION EXTENDING THE ELIGIBILITY PERIOD OF PROPERTY OWNERS
AFFECTED BY THE SAND FIRE AND KING FIRE FOR PERMIT FEE WAIVERS*

WHEREAS, California Governor Jerry Brown declared a State of Emergency on August 2, 2014 due to a number of fires in the state, including the Sand Fire in El Dorado County and on September 17, 2014 Governor Jerry Brown declared a State Emergency due to the King Fire in El Dorado County; and

WHEREAS, as a result of the Sand Fire and King Fire, serious health and safety hazards currently exist from fire debris, including unstable structures and harmful chemicals that are likely to remain on affected parcels, such hazards requiring attention and constituting a local emergency; and

WHEREAS, the expeditious demolition of damaged structures and facilitation of the rebuilding and upgrading of the structures, including making the structures more fire-resistant, is in the best interest of the citizens of El Dorado County; and

WHEREAS, the provision of fee waiver extensions will provide critical relief to victims of the Sand Fire and King Fire, expedite the permitting process and waive permit fees for legally built structures that have been destroyed; such relief is deemed to serve a public purpose; and

WHEREAS, section 15.16.020 of the El Dorado County Code states that "all matters pertaining to fees are as established by resolution of the El Dorado County Board of Supervisors."

NOW, THEREFORE, BE IT RESOLVED

Section 1. The Board of Supervisors hereby extends the waivers of all County permit fees associated with the property owner, of record at the time of the Sand Fire and King Fire, removing, repairing and/or rebuilding the equivalent square footage of previously existing and damaged legally permitted homes and structures (including accessory buildings) within the burn areas of the Sand Fire and King Fire.


Section 2. All such County permit applications must be submitted to the Development Services Agency by February 28, 2017.


