## COMMERCIAL GRADING

### *Checklist for Submittal of Commercial Grading Plans*

**Applicant to check boxes indicating those items supplied with submittal:**

- Permit Application, signed by owner of record or agent. Fee is \$100.00.
- Agreement For Payment, **signed by property owner of record**, or by agent if notarized letter of authorization from owner is provided. Provide evidence of ownership for corporations such as LLCs.
- Signed and wet-stamped engineers estimate (the fee deposit schedule is based on engineers estimate - plan check deposit is 1% of engineers estimate, or \$1,000.00, whichever is greater). Note that at time of submittal a Resource Conservation District (RCD) fee of \$400.00 is due.
- 5 sets of sealed & signed plans prepared under the direction of a California registered civil engineer. Plans to include landscape and lighting sheets. We will distribute 2 sets to DOT and set 1 to RCD.
- 3 copies of the Conditions of Approval, or for discretionary projects that have not received approval, attach a signed "Early Application Submittal" sheet (page 8 of the green Non-Res Checklist).
- 2 copies of the Drainage Report.
- 2 copies of the Soils Report.
- 2 copies of [STORM WATER POST CONSTRUCTION REQUIREMENTS](#) (if not included in drainage report). [Storm Water Management Info](#) (Ctrl+click to follow description link)
- 2 copies of engineering calculations and construction details for retaining walls.
- One copy of a Preliminary Title Report.
- One copy of application to State Water Resources Control Board (SWRCB) for Notice of Intent (NOI) if one acre or more is disturbed.
- One copy of permit application to Army Corps of Engineers or Dept. of Fish & Game, if applicable.
- General Plan Consistency Checklist completed and signed.
- A brief written description of the project for which the grading is proposed.

Note: Road encroachment permits will be issued by DSD or DOT, depending on the road type and location. Contact Caltrans District 3 (530-741-4211) for encroachments onto state highways.

***Submittals that do not contain all of the required items will not be accepted.***
