NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that the County of El Dorado, State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: CSA 5 Erosion Control Project

LOCATION: The Project is located in eastern El Dorado County, within the Lake Tahoe Basin, in Tahoma near the west shore of Lake Tahoe. The Project area is bounded by Lake Tahoe and First Avenue to the east, the El Dorado/Placer County Line to the north, Chinkapin Road and Placer Street to the west, and Cedar Street to the south.

APN: County road right-of-way and APNs 014-302-02, 014-303-12, 015-063-18.

GENERAL DESCRIPTION: El Dorado County Community Development Agency, Transportation Division, is proposing to: install erosion control and water quality improvements to reduce the discharge of sediment and pollutants to Lake Tahoe from County administered rights-of-way. The improvements will be to the existing storm water conveyance system which is comprised of channels, basins, culverts, inlets, infiltration system, and slope protection.

REVIEW: The review period for the Mitigated Negative Declaration begins on February 25, 2016 and ends on March 25, 2016. The Mitigated Negative Declaration may be reviewed at County Transportation offices at 924B Emerald Bay Road, South Lake Tahoe, CA.
