NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that the County of El Dorado, State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: Clear Creek Road at Clear Creek Bridge (25C0080) Replacement Project (County CIP #77138)

LOCATION: The Project is located Approximately 1.82 miles east of the Clear Creek Road-Sly Park Road intersection in the Pleasant Valley community of unincorporated El Dorado County

APN: County road right-of-way.

GENERAL DESCRIPTION: El Dorado County Community Development Agency, Transportation Division, in conjunction with Caltrans and FHWA, is proposing to: (1) replace the existing, structurally deficient, one-lane, 28 feet long, 14 feet wide, single-span bridge structure, with a new concrete bridge approximately 45 feet long and 26 feet wide, that meets current standards, and; (2) widen the road geometry approaching the bridge from both east-bound and west-bound directions. The existing bridge was determined to be structurally deficient with a sufficiency rating of 33.5 out of 100. The new bridge would have two 10-foot lanes and two 3-foot shoulders and guardrails. Construction of the new bridge would be implemented in stages to allow vehicle traffic during the construction period. For a more detailed project description, see the document available as described below.

REVIEW: The review period for the Mitigated Negative Declaration begins on April 10, 2015 and ends on May 11, 2015. The Mitigated Negative Declaration may be reviewed at County Transportation offices at 2850 Fairlane Court, Placerville, CA.
