 - Public Safety - Sheriff's report, CHP report and EDH Fire report – Fire Chief Mike Lilienthal discussed the wildfire readiness training that all in the fire department have completed. The defensible space inspectors are out and engaged and connected with the community. Two new firefighters have been hired and EDH fire is well staffed. Fire training center continues to be built and should be done by April 2023. Recent fire by Blue Shield started by a lawn mower and burned 26 acres. - Infrastructure- CEDHSP Planning Commission Hearing Highlights - The EDC Planning Commission voted 4-1 to not certify the CEDHSP Revised Final Environmental Impact Report. In addition, the commission voted 5-0 to deny the CEDHSP project noting the reason for recommending denial was the project is inconsistent with the General Plan.
- Good Governance- Letter to the Editor (Mountain Democrat) – Scott Taylor wrote a letter to the editor giving kudos to the BOS for looking into a biomass generator for future energy production.
