**El Dorado County to Extend Closure of Clear Creek Road at Post Mile 1.82 for Bridge Replacement Construction and Related Work  
Approximate Dates June 17, 2020 – October 30, 2020**

**UPDATE:** September 18, 2020

El Dorado County Department of Transportation is extending the road closure through October 30, 2020 at the Clear Creek Road Bridge Replacement Project over Clear Creek at Post Mile 1.82 in the interest of public safety and reducing the overall impact times to the traveling public.


The bridge construction project has several safety features to complete before it can be fully open to two lanes of traffic. Road maintenance will also be conducted along other areas of Clear Creek Road during this closure period.

The informational Portable Changeable Message Sign and the emergency access road through the job site will be maintained until the closure period is over. This road closure time extension will reduce potential conflicts of the traveling public with construction and maintenance equipment, providing a safer and earlier project completion.

Motorists are advised that local traffic north of the bridge construction will be routed to either Sierra Springs Drive (Detour 1) or Starkes Grade Road (Detour 2). Motorists are also advised to allow extra time when traveling to account for the detour in order to arrive at their destinations on time.

The County sincerely appreciates the cooperation and patience of motorists that use this roadway and we apologize for any inconvenience as a result of these closures.
