The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on September 16, 2020, at 3:00 p.m., to consider the following: Tentative Parcel Map Time Extension P-E20-0001/Rossbach submitted by GERALD ROSSBACH AND RANDAL READING request for four (4) one-year time extensions to the approved Tentative Parcel Map P16-0007 creating two parcels, resulting in a new expiration date of April 19, 2024. The property, identified by Assessor's Parcel Number 069-220-030, consisting of 10.94 acres, is located on the west side of North Shingle Road, approximately 25 feet west of the intersection with Choopim Road, in the Shingle Springs area, Supervisorial District 4.
