The County of El Dorado Zoning Administrator will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on October 6, 2021, at 3:00 p.m., to consider the following: Tentative Parcel Map P21-0003 and Administrative Permit ADM21-0020/Vandegrift submitted by WILLIAM AND KATHY VANDEGRIFT for the following: 1) Tentative Parcel Map dividing a 20-acre parcel into two parcels of ten-acres each; and 2) Administrative Permit to reduce the 200-foot setback from agriculturally zoned parcels to the base zone setback standard of 30-feet. The property, identified by Assessor's Parcel Number 109-320-007, consisting of 20 acres, is located on the east side of Barnett Ranch Road, approximately 50-feet west of the intersection with Cattle Drive, in the Shingle Springs area, Supervisorial District 2.
