

**NOTICE OF ELECTIONS

**GILMORE VISTA ZONE OF BENEFIT #98122
MEASURE A**

NOTICE IS HEREBY GIVEN to the qualified electors of the Gilmore Vista Zone of Benefit #98122 that the County of El Dorado Board of Supervisors has called for an election to be held May 7, 2013.

“Shall an annual special tax in an amount of \$270.00 on each improved parcel of real property and in an amount of \$120.00 on each unimproved parcel of real property be levied within Gilmore Vista Zone of Benefit commencing fiscal year 2013/2014 to be used only for road improvement and maintenance services, to replace the current benefit assessment?”

NOTICE IS FURTHER GIVEN that this measure shall be called **Measure A**.

**MEADOWVIEW ACRES ZONE OF BENEFIT #98125
MEASURE B**

NOTICE IS HEREBY GIVEN to the qualified electors of the Meadowview Acres Zone of Benefit #98125 that the County of El Dorado Board of Supervisors has called for an election to be held May 7, 2013.

“Shall an annual special tax in an amount of \$350.00 on each parcel of real property be levied within Meadowview Acres Zone of Benefit commencing fiscal year 2013/2014 to be used only for road improvement and maintenance services, to replace the current benefit assessment?”

NOTICE IS FURTHER GIVEN that this measure shall be called **Measure B**.

Arguments for and against these measures may be submitted between the dates of **Monday, January 7, 2013 and Monday, January 14, 2013 at 5:00 p.m.** **Primary arguments** for and against these measures **shall not exceed 300 words** in length and shall not be accepted unless accompanied by the name(s) and address(es) of the person(s) submitting them. **Person turning in an argument MUST be a registered voter in the district.** **No more than five signatures** shall appear with any argument and original signatures are necessary.

BE FURTHER ADVISED that **rebuttal arguments for or against** said measures must be submitted **no later than Tuesday, January 22, 2013.** Rebuttal arguments **shall not exceed 250 words** in length and follow the same laws as primary arguments with regard to names, signatures and argument submission. All arguments and rebuttals must be **submitted in person, or by certified mail** to the Registrar of Voters, Elections Department, 2850 Fairlane Court, Placerville, CA 95667.

The Elections Department shall be open from 7:00 a.m. until 8:00 p.m. on Election Day, May 7, 2013. The ballots will be counted beginning at 8:00 a.m. on Wednesday, May 8, 2013 at the Elections Department, 2850 Fairlane Court, Placerville. The public is invited to observe.
