Briefly Describe the environmental setting: The project area is located in the western slope of the central Sierra Nevada mountains, in an area classified as the Yellow Pine Belt. The project area lies at an elevation of approximately 2,200 feet. Species identified within and near the project area include black oak, yellow pine, incense cedar, interior live oak, Manzanita, willow, California blackberry, buckbrush, and kit-kit-dizze. One intermittent channel exists in the western portion of the project area. This channel is identified on the USGS Camino quad as an unnamed tributary of Clear Creek. Most of the project area is covered with annual grasses and widely scattered oaks, with the exception of along the creek corridor that includes a dense stand of oaks and willow, with scattered pines. No permanent water exists within the project area. The site has been developed with a single-family dwelling and a garage. Future plans include an office building and required parking lot, permits for which have already been issued by Building Services.

Discussion:

A substantial adverse effect to Visual Resources would result in the introduction of physical features that are not characteristic of the surrounding development, substantially change the natural landscape, or obstruct an identified public scenic vista.

- a,b) No scenic vistas, resources, trees, rock outcroppings, historic buildings or designated scenic highways would be affected by this project.
- c) The parcel map will result in two parcels which are suitable for commercial use. While the surrounding neighborhood to the north and west has been developed for residential use, the adopted General Plan land use and Zoning designations for the parcel earmark it for commercial development, likely due to its adjacency to Pleasant Valley Road and Pleasant Valley proper. As the parcel could currently be developed with commercial uses, and no changes to the General Plan land use or Zoning designation are proposed as part of this project, the proposed parcel split would have a less than significant impact on the visual character or quality of the site.
- d) There is no lighting proposed as part of this project. All future building plans issued for the parcel(s) must comply with Section 17.14.170 of the County Zoning Ordinance which prohibits unnecessary and unwarranted illumination of an adjacent property.

FINDING: For this “Aesthetics” category, the thresholds of significance have not been exceeded. No impacts from light and glare are expected and no mitigation is required.

Discussion:

A substantial adverse effect to Agricultural Resources would occur if:

- There is a conversion of choice agricultural land to nonagricultural use, or impairment of the agricultural productivity of agricultural land;
 - The amount of agricultural land in the County is substantially reduced; or
 - Agricultural uses are subjected to impacts from adjacent incompatible land uses.
- a) El Dorado County has established the Agricultural (A) General Plan land Use Overlay district and included this overlay on the General Plan Land Use Maps. Review of the General Plan Land Use Map for the project area indicates that there are no areas of “Prime Farmland” or properties designated as being within the Agricultural (A) General Plan Land Use Overlay District area adjacent to the project site. The project would not result in the conversion of farmland to non-agricultural uses because there are no adjacent agriculturally zoned properties.
- b) The proposed project would not conflict with any agricultural use in the project vicinity, and would not adversely impact properties currently under a Williamson Act Contract.
- c) No existing agricultural land would be converted to non-agricultural use as a result of the proposed project.

FINDINGS: It has been determined that the project would not result in any impact to agricultural lands, or properties subject to a Williamson Act Contract. The surrounding area mainly consists of residential development. For this “Agricultural” category, the identified thresholds of significance have not been exceeded and no significant adverse environmental effects would result from the project.

Discussion:

A substantial adverse effect on Air Quality would occur if:

- Emissions of ROG and No_x, will result in construction or operation emissions greater than 82lbs/day (See Table 5.2, of the El Dorado County Air Pollution Control District – CEQA Guide);
- Emissions of PM₁₀, CO, SO₂ and No_x, as a result of construction or operation emissions, will result in ambient pollutant concentrations in excess of the applicable National or State Ambient Air Quality Standard (AAQS). Special standards for ozone, CO, and visibility apply in the Lake Tahoe Air Basin portion of the County; or
- Emissions of toxic air contaminants cause cancer risk greater than 1 in 1 million (10 in 1 million if best available control technology for toxics is used) or a non-cancer Hazard Index greater than 1. In addition, the project must demonstrate compliance with all applicable District, State and U.S. EPA regulations governing toxic and hazardous emissions.

a,b) Site clearing, burning, grading, utility excavation, and movement of construction equipment would create temporary air quality impacts during construction. The construction-related impacts should be less than significant since these aspects of the project would be controlled by Chapter 15.14 of the County Code which sets minimum standards for such activities and El Dorado Air Pollution Control District Rule 223 that controls fugitive dust.

c) Regarding cumulative air quality impacts, the proposed project does not require a change in existing land use designation or exceed the project alone significance criteria. Based on the project information provided, the proposed project would not result in any cumulatively considerable net increase of any criteria pollutant for which the project region is in non-attainment under an applicable federal or state ambient air quality standard.

d) The proposed project is not considered to be a sensitive receptor. There are no existing uses considered to be sensitive receptors located near the project site. Therefore, the proposed project would not expose sensitive receptors to substantial pollutant concentrations.

e) The proposed commercial parcels are not a use that commonly produces odors. It has been determined that the proposed project would not create objectionable odors affecting a substantial number of people.

FINDINGS: It was determined that a less than significant impact would result from the project because it would not obstruct implementations of the El Dorado County California Clean Air Act Plan; violate any air quality standard; result in a cumulatively considerable net increase of any criteria pollutant for which the project region is in non-attainment under an applicable federal or state ambient air quality standard; expose sensitive receptors to substantial pollutant concentrations; or create objectionable odors affecting a substantial number of people.

Discussion:

A substantial adverse effect on Biological Resources would occur if the implementation of the project would:

- Substantially reduce or diminish habitat for native fish, wildlife or plants;
- Cause a fish or wildlife population to drop below self-sustaining levels;
- Threaten to eliminate a native plant or animal community;
- Reduce the number or restrict the range of a rare or endangered plant or animal;
- Substantially affect a rare or endangered species of animal or plant or the habitat of the species; or
- Interfere substantially with the movement of any resident or migratory fish or wildlife species.

- a) After Reviewing County resource materials for sensitive and protected species, it has been determined that the project would not affect locally designated natural communities, disturb wetlands, or affect migration corridors.
- b,c) The U.S. Department of Interior National Wetlands Inventory Maps were reviewed and subsequent site visit was completed. Two areas of special concern were found on the subject property: an intermittent stream running roughly northeast to southwest across the northwestern part of the parcel and a potential seasonal wetland area located in the southwestern quadrant of the parcel. The intermittent stream is mapped on the Camino quad as an unnamed tributary to Clear Creek. Both features are protected by the placement of a 50-

foot non-building setback on the tentative parcel map, as prescribed by General Plan Policy 7.3.3.4, and analyzed within the General Plan EIR.

- d) Review of the Planning Division GIS *Deer Ranges Map* (January 2002) indicates that there are no mapped critical deer migration corridors on the project site. The project would not substantially interfere with the movement of any native resident migratory fish or wildlife species or with any established native resident or migratory wildlife corridors, or impede the use of wildlife nursery sites.
- e,f) After review of a biological resources study provided as part of project submittal, it has been found that the project does not conflict with any local policies or ordinances protecting biological resources, nor the provisions of an adopted Habitat Conservation Plan (HCP), Natural Community, Conservation Plan, or other approved local, regional, or state habitat conservation plan (*Biological Resources Evaluation for the Hall Tentative Map Project*, 2008). These include oak woodland preservation, rare plants and special-status species, and wetland preservation with the goal to preserve and protect sensitive natural resources within the County. As proposed, the project will require no tree removal. Should future commercial development result in tree removal, any ministerial building permit would be required to mitigate any canopy loss, pursuant to the El Dorado County Oak Woodland Management Plan, adopted May 2008.

FINDING: It has been determined that all potential biological resource impacts as a result of the proposed project are less than significant. Therefore, the established thresholds for significance in the “Biological Resources” category would not be exceeded.

Discussion:

In general, significant impacts are those that diminish the integrity, research potential, or other characteristics that make a historical or cultural resource significant or important. A substantial adverse effect on Cultural Resources would occur if the implementation of the project would:

- Disrupt, alter, or adversely affect a prehistoric or historic archaeological site or a property or historic or cultural significant to a community or ethnic or social group; or a paleontological site except as a part of a scientific study;
- Affect a landmark of cultural/historical importance;
- Conflict with established recreational, educational, religious or scientific uses of the area; or
- Conflict with adopted environmental plans and goals of the community where it is located.

- a,b) The applicant supplied a Record Search completed by Historic Resource Associates. This Record Search indicated a moderate possibility of identifying Native American (prehistoric) and a high possibility of identifying historic-period cultural resources in the project area. Based on the Record Search results, it was determined that further archival or field study would be required. This field study was performed by Historic Resource Associates in June, 2008. This field investigation found no significant prehistoric or historic archaeological sites, features, or artifacts in the project area. Further, no historic buildings, structures, or objects were found within the project area.
- c) A unique paleontological site would include a known area of fossil bearing rock strata. The project site does not contain any known paleontological site or known fossil locales.
- d) Due to the scope of the project, there is not a high potential to discover human remains outside of a dedicated cemetery. However, in the event of the accidental discovery or recognition of any human remains in any location other than a dedicated cemetery, the County has mitigation measures in place pursuant to Section 7050.5 of the Health and Safety Code and Section 5097.98 of the Public Resources Code, that in the event of the discovery of human remains, all work is to stop and the County Coroner shall be immediately notified. If the remains are determined to be Native American, the Coroner must contact the Native American Heritage Commission within 24 hours. The treatment and deposition of human remains shall be completed consistent with guidelines of the Native American Heritage Commission.

FINDING: Although the project has the potential to impact sub-surface cultural or historic resources, or disturb human remains located outside of a designated cemetery, the application of the standard conditions of approval identified in Attachment 1 of the staff report address such impacts. Established thresholds of significance would not be exceeded within the “Cultural Resources” category.

Discussion:

A substantial adverse effect on Geologic Resources would occur if the implementation of the project would:

- Allow substantial development of structures or features in areas susceptible to seismically induced hazards such as groundshaking, liquefaction, seiche, and/or slope failure where the risk to people and property resulting from earthquakes could not be reduced through engineering and construction measures in accordance with regulations, codes, and professional standards;
 - Allow substantial development in areas subject to landslides, slope failure, erosion, subsidence, settlement, and/or expansive soils where the risk to people and property resulting from such geologic hazards could not be reduced through engineering and construction measures in accordance with regulations, codes, and professional standards; or
 - Allow substantial grading and construction activities in areas of known soil instability, steep slopes, or shallow depth to bedrock where such activities could result in accelerated erosion and sedimentation or exposure of people, property, and/or wildlife to hazardous conditions (e.g., blasting) that could not be mitigated through engineering and construction measures in accordance with regulations, codes, and professional standards.
- a) As shown in the Division of Mines and Geology’s publication Fault Rupture Hazard Zones in California, there are no Alquist-Priolo Special Studies Zones mapped for El Dorado County. The impacts from fault ruptures, seismically induced groundshaking, or seismic ground failure or liquefaction are considered to be less than significant. Any potential impact caused by locating buildings in the project area would be offset by the compliance with the Uniform Building Code earthquake standards. The project is not located in an area with significant topographic variation in slope. Therefore, the potential for mudslides or landslides is less than significant.
- b) No grading has been proposed as part of this project. However, any grading activities shall comply with the El Dorado County Grading, Erosion, and Sediment Control Ordinance, which would reduce any potential impacts to a less than significant level.
- c,d) Because future grading and/or improvement activities must comply with the *El Dorado County Grading, Erosion, and Sediment Control Ordinance*, to include the implementation of pre- and post-construction Best Management Practices (BMPs) to reduce and eliminate run-off, there will be a less than significant impact within this category. The soil types that exist on this property can adequately support the type of development that would be required for this project, that is commercial development and associated parking. The mapped soils include Josephine Silt Loam, 5-15% slopes (JtC), Mixed alluvial land (MpB), and Placer diggings (PrD) (*Soil Survey on El Dorado Area, California, 1974*). The site is not comprised of expansive soils, and is suitable for the existing non-conforming residential use, as well as the permitted but not yet constructed commercial use

on proposed parcel two. The project would require all future improvement activities to either parcel to implement the requirements established by the *El Dorado County Grading, Erosion and Sediment Control Ordinance* and any future building designs to implement Uniform Building Code Seismic construction standards.

- e) The applicant provided a Report of Percolation Test. The El Dorado County Environmental Management Department has reviewed the project, approved the report, and has previously permitted an on-site septic disposal system on proposed parcel two.

FINDINGS: No significant impacts would result from geological or seismological anomalies on the project site. The site does not contain expansive soils or other characteristics that would result in significant impacts. For the “Geology and Soils” category, established thresholds would not be exceeded by development of the project and no significant adverse environmental effects would result from the project.

Discussion:

A substantial adverse effect on Hydrology and Water Quality would occur if the implementation of the project would:

- Expose residents to flood hazards by being located within the 100-year floodplain as defined by the Federal Emergency Management Agency;

- a) The parcel map will result in two lots suitable for commercial use. While each of the proposed parcels currently has some form of development, at the building permit stage for any future development, the applicant would be required to submit a preliminary drainage plan and erosion control plan, which is reviewed by Building Services. Compliance with the Erosion Control Plan would limit water runoff and discharge that would violate water quality standards or discharge requirements established by the Regional Water Quality Control Board. Permit applicants are required to prepare and retain on the construction site, a Storm-water Pollution Prevention Plan that describes the site, erosion and sediment controls, means of waste control, implementation of local plans required by the Resource Conservation District, control of post-construction sediment and erosion control, and non storm-water management controls.
 - b) The project would have no impact on the groundwater in the vicinity, as the applicant would be connected to a public water supply via the El Dorado County Irrigation District (EID).
 - c) There is no evidence that future grading and ground disturbances associated with the project would substantially alter the existing drainage patterns on or off the site. *The Grading, Erosion, and Sediment Control Ordinance* contains specific requirements which limit the impacts to a drainage system (County Code Sections 15.14.440 & 15.14.590). The standards would apply to this project if and when a building permit request is submitted to the County.
 - d,e) In this case, the project may include a moderate amount of grading for road improvements. However, at the time a grading or building permit request is submitted to the County an erosion control plan would be required to reduce erosion and sediment discharge off the site to a less than significant level.
 - f) The project would not result in substantial degradation of water quality in either surface or sub-surface water bodies in the vicinity of the project area. All storm-water and sediment control methods contained in the *Grading, Erosion, and Sediment Control Ordinance* must be met during all construction activities, as well as the required development of any permanent storm drainage facilities and erosion control measures on the project site.
 - g,h) The Flood Insurance Rate Map (Panel 060040 0775 B, 10/18/83) for the project area establishes that the project site is not located within a mapped 100-year floodplain.

- Substantially increase or expand the demand for fire protection and emergency medical services without increasing staffing and equipment to meet the Department’s/District’s goal of 1.5 firefighters per 1,000 residents and 2 firefighters per 1,000 residents, respectively;
- Substantially increase or expand the demand for public law enforcement protection without increasing staffing and equipment to maintain the Sheriff’s Department goal of one sworn officer per 1,000 residents;
- Substantially increase the public school student population exceeding current school capacity without also including provisions to adequately accommodate the increased demand in services;
- Place a demand for library services in excess of available resources;
- Substantially increase the local population without dedicating a minimum of 5 acres of developed parklands for every 1,000 residents; or
- Be inconsistent with County adopted goals, objectives or policies.

a) **Fire Protection:** The El Dorado County Fire Protection District currently provides fire protection services to the project area. Development of the project would result in a minor increase in the demand for fire protection services, yet would not prevent the Fire Department from meeting its response times as the project area is located immediately adjacent to the District’s Pleasant Valley Station . The El Dorado County Fire Protection District would review any future building permit applications to ensure compliance with fire standards including, but not limited to: location of fire hydrants, accessibility around buildings, turning radii within parking areas, fire sprinklers within buildings, and building identification.

- b) **Police Protection:** The project site would be served by the El Dorado County Sheriff’s Department with a response time depending on the location of the nearest patrol vehicle. The minimum Sheriff’s Department service standard is an 8-minute response to 80 percent of the population within Community Regions. For the rural areas, there is no standard minimum level of service or response time. Currently, the County has 0.89 sworn officers per 1,000 daytime populations. The Sheriff’s Department stated goal is to achieve a ratio of one sworn officer per 1,000 residents. The addition of a residential parcels and the related development would not significantly impact the achievement of this goal, or significantly impact the current response times to the project area.
- c) **Schools:** The project site is located within the Gold Oak Union School District. As the project would create two parcels with Commercial General Plan and Zoning designations, there will be no impact on the affected school district.
- d) **Parks:** As the project would create two parcels with Commercial General Plan and Zoning designations, there will be no impact the local population necessitating the development of new park facilities.
- e) No other public facilities or services would be substantially impacted by the project.

FINDING: Adequate public services are available to serve the project. Therefore, there is no potential for a significant impact due to the development of the subject parcel either directly or indirectly. No significant public service impacts are expected. For this “Public Services” category, the thresholds of significance have not been exceeded.

Discussion:

A substantial adverse effect on Utilities and Service Systems would occur if the implementation of the project would:

- Breach published national, state, or local standards relating to solid waste or litter control;
- Substantially increase the demand for potable water in excess of available supplies or distribution capacity without also including provisions to adequately accommodate the increased demand, or is unable to provide an adequate on-site water supply, including treatment, storage and distribution;

a,b,e)The existing, permitted on-site septic system serving proposed parcel two has been reviewed and approved by the Environmental Management Department. As a requirement of project submittal, an onsite sewage disposal feasibility report was prepared and provided to the Department. This report has been approved by Environmental Management, assuring adequate septic capability for the undeveloped parcel (parcel one). Any septic system required during site development will be required to be permitted by Environmental Management. As sewage and wastewater will be disposed on-site, no impact to off-site treatment providers will occur.

c) On-site drainage facilities are required as needed so as to reduce runoff to discharge levels, which do not exceed site discharge levels, which existed prior to development of the site. All drainage facilities should be designed in conformance with the standards contained in the “County of El Dorado Drainage Manual.”

d) Both the developed site (parcel two) and the as of yet undeveloped site (parcel one) would be served by public water from the El Dorado Irrigation District. A facility improvement letter (FIL), dated March 31, 2008, was provided by the District. This letter addresses the location and approximate capacity of existing water service facilities in the project vicinity. The letter calls out the need for the applicant to extend existing service from either Alameda Road (to the east) or Pleasant Valley Road (to the southwest). Satisfactory easements can be found near Pleasant Valley Road, with the easement actually crossing the subject parcel. The project, as conditioned will have adequate water supply.

f,g) In December of 1996, direct public disposal into the Union Mine Disposal Site was discontinued and the Material Recovery Facility/Transfer Station was opened. Only certain inert waste materials (e.g., concrete, asphalt, etc.) may be dumped at the Union Mine Waste Disposal Site. All other materials that cannot be recycled are exported to the Lockwood Regional Landfill near Sparks, Nevada. In 1997, El Dorado County signed a 30-year contract with the Lockwood Landfill Facility for continued waste disposal services. The Lockwood Landfill has a remaining capacity of 43 million tons over the 655-acre site. Approximately six million tons of waste was deposited between 1979 and 1993. This equates to approximately 46,000 tons of waste per year for this period.

After July of 2006, El Dorado Disposal began distributing municipal solid waste to Forward Landfill in Stockton and Kiefer Landfill in Sacramento. Pursuant to El Dorado County Environmental Management Solid Waste Division staff, both facilities have sufficient capacity to serve the County. Recyclable materials are

distributed to a facility in Benicia, and green wastes are sent to a processing facility in Sacramento. Impacts would be less than significant.

FINDING: No significant impacts would result to utility and service systems from development of the project. For the “Utilities and Service Systems” section, the thresholds of significance have not been exceeded and no significant environmental effects would result from the project.

Discussion:

- a) There is no substantial evidence contained in the record that the project would have the potential to degrade the quality of the environment. The project does not have the potential to substantially reduce the habitat of a fish or wildlife species, cause a fish or wildlife population to drop below self-sustaining levels, threaten to eliminate a plant or animal community, reduce the number or restrict the range of a rare or endangered plant or animal or eliminate important examples of California history or pre-history. Any impacts from the project would be less than significant due to existing standards and requirements imposed in the conditioning of the project.
- b) Cumulative impacts are defined in Section 15355 of the California Environmental Quality Act (CEQA) Guidelines as “two or more individual effects, which when considered together, are considerable or which compound or increase other environmental impacts.” Based on the analysis in this Initial Study, it has been determined that the project would not result in cumulative impacts.
- c) Based upon discussion contained in this document, it has been determined that the project would not have any environmental effects which cause substantial adverse effects on human beings, either directly or indirectly.
