Project Applicants: It is important that the applicant or applicant's representative attend the hearing no later than 3:00 P.M., as agenda items may be heard out of order and hearings often proceed quickly. If attendance is not possible, the project planner should be contacted prior to the hearing.

- b. **S02-0031-R** Special Use Permit-Revision Coloma Grange Hall/Gold Panning & Education Facility submitted by JUDY BARADIN and RUSSELL KRUZ to allow the installation of six gold panning troughs and an eight-foot by 40-foot pine frame, canvas cover structure used for educational purposes. The property, identified by Assessor's Parcel Number 006-164-02, consisting of 0.43 acres, is located on the northeast corner of State Route 49 and Mount Murphy Road, in the **Coloma area**, (next to Marshall Gold Discovery Historic State Park) Supervisorial District IV. [*Project Planner: Jason R. Hade*] (Categorical Exemption pursuant to Section 15303(e) of the CEQA Guidelines)*
