- a. **S64-0012-R Special Use Permit-Revision** submitted by VERIZON WIRELESS (Complete Wireless Consulting, Mark Lobaugh) to allow the addition of six (6) new wireless antennas and the removal of four (4) existing omni antennas on an existing building mounted tower. The property, identified by Assessor's Parcel Number 046-081-22, consisting of 1.02 acres, is located on the south side of Tower Road, one half mile north east of the intersection with Mt Aukum Road (County Route E16), in the Mt Aukum area, Supervisorial District II. [*Project Planner: Aaron Mount*] (Categorical Exemption pursuant to Section 15301 of the CEQA Guidelines)\*

- b. **S05-0045-R Special Use Permit-Revision** submitted by CLEARWIRE WIRELESS BROADBAND (Agent: Landmark Global Consulting, Karen Lienert) to allow the collocation of three wireless antennae and three microwave dishes on an existing lighting standard. The antennae would be mounted at 59 feet and the dishes would be located at 63 feet. Associated ground mounted equipment would be located within a new 113 square foot lease area. The property, identified by Assessor's Parcel Number 325-290-06, consisting of 38.09 acres, is located at Oak Ridge High School on the south side of Harvard Way, 300 feet west of the intersection with Silva Valley Parkway, in the El Dorado Hills area, Supervisorial District II. [*Project Planner: Jonathan Fong*] (Categorical Exemption pursuant to Section 15301 of the CEQA Guidelines)\*
