# Exhibit C: General Plan Map

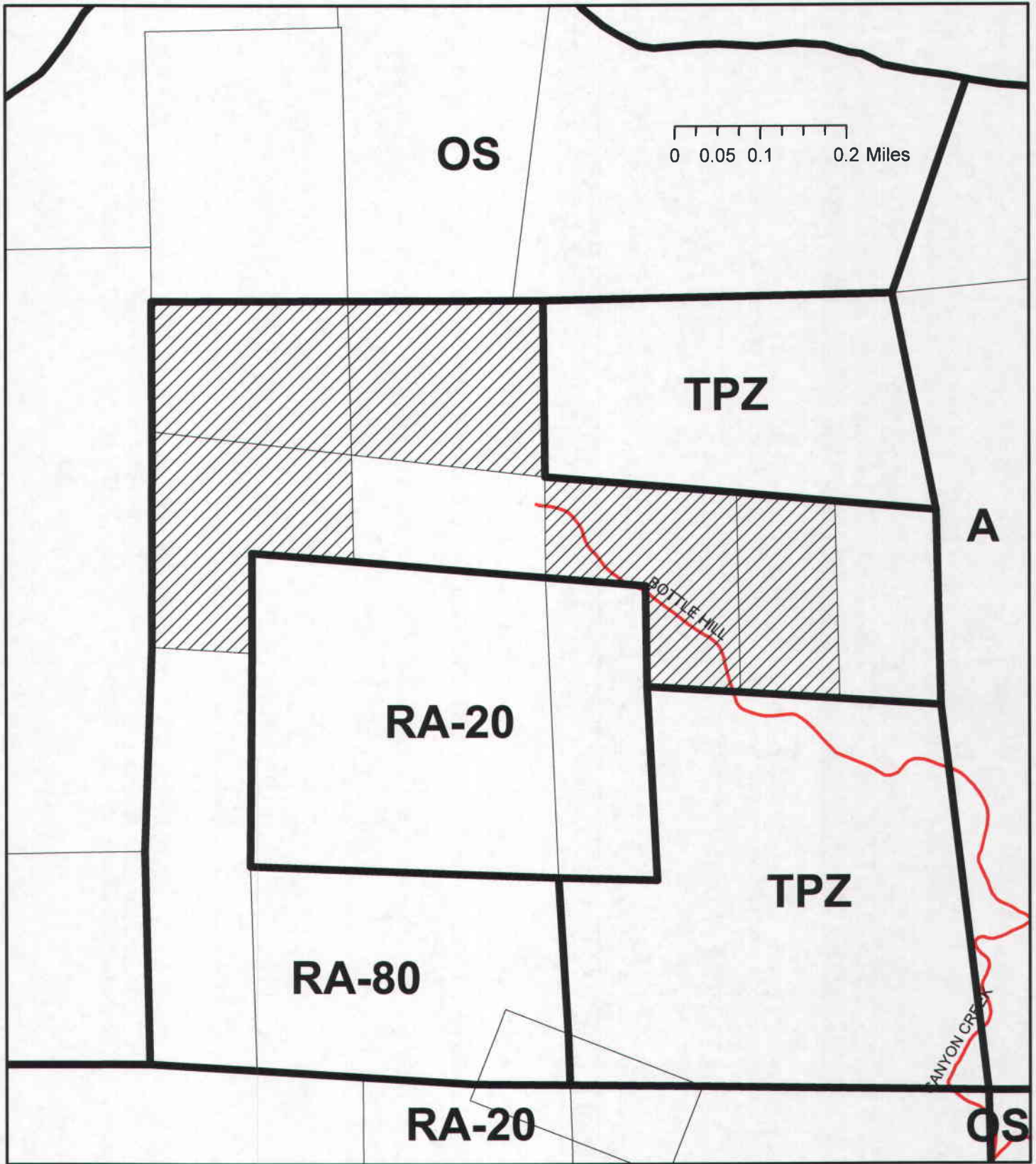

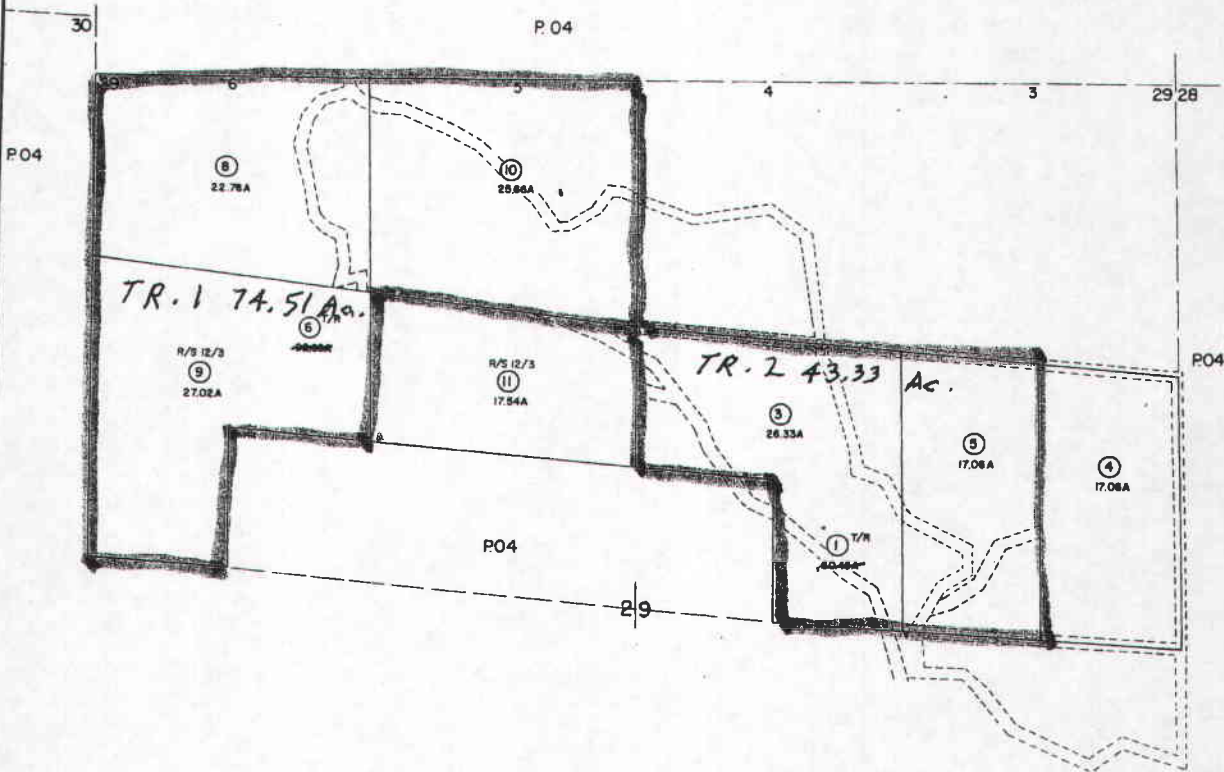

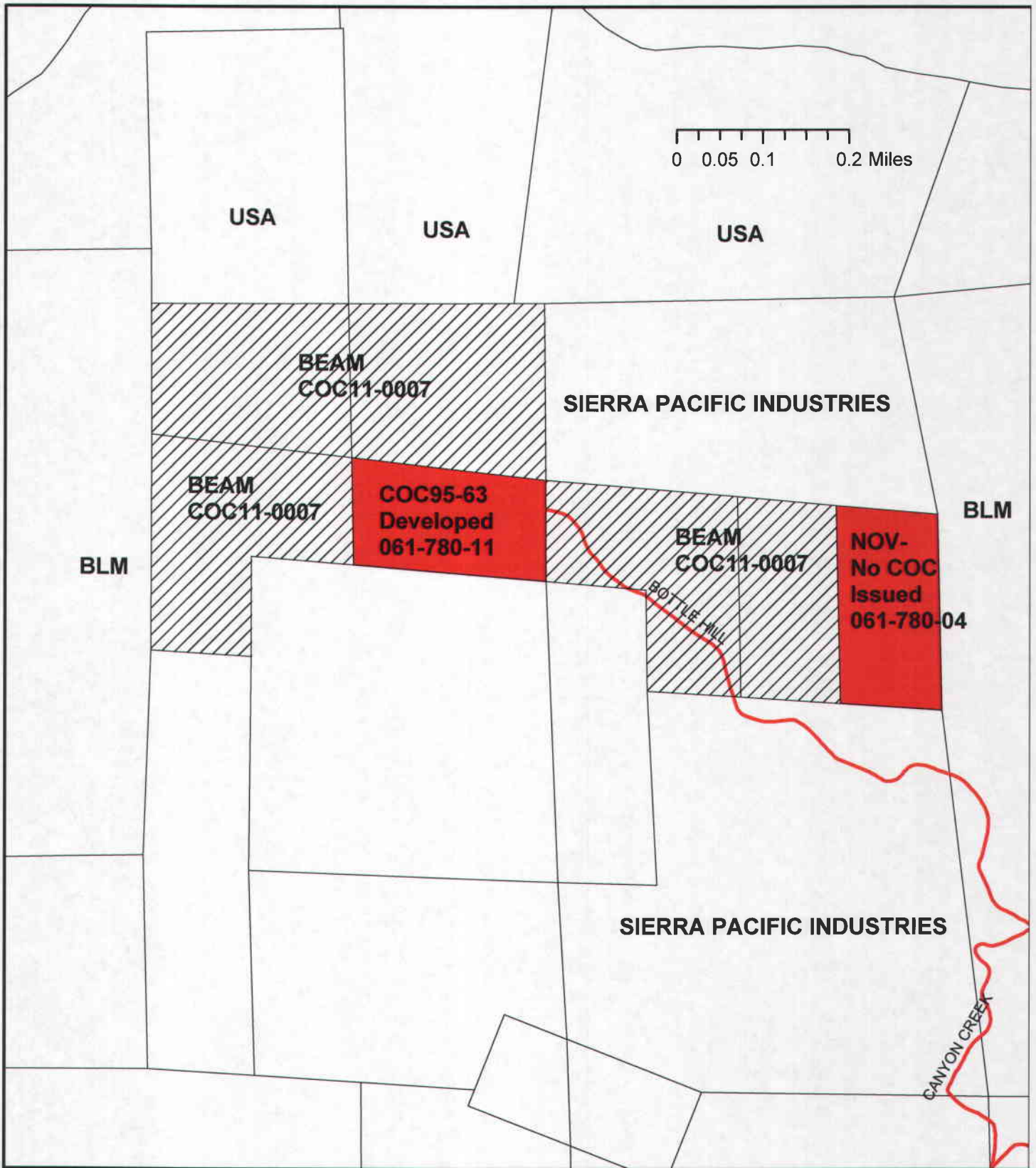
