The property, identified by Assessor's Parcel Number 038-050-16, consisting of 0.89 acres, is located on the north side of Tamarack Pines Road, approximately 150 feet east of the intersection with US Highway 50, **in the Mount Ralston Rural Center**, Supervisorial District 5. [*Project Planner: Aaron Mount*] (Categorical Exemption pursuant to Section 15303 of the CEQA Guidelines)*
